

## Development Proposals

Your committee spent a great deal of thought and time preparing the response from The Friends of the Forster Country to the housing proposals of North Herts District Council (NHDC). Public Consultation lasted just over six weeks and closed on 28 March 2013. Seven areas (strategic sites) in North Herts are each being considered as options for the building of more than a thousand homes over the next twenty years, in addition to smaller developments in towns and villages (non-strategic sites).

The seven sites to be considered were proposed by landowners and developers. The public were asked to respond in order to aid in the choice of sites as Councillor Tom Brindley (Portfolio Holder for Planning, Transport and Enterprise NHDC) stated that a third of them will need to be built on. There is a target of 10,700 homes to be built by 2031 in order to meet the area's expected future needs.

Six of the seven sites proposed lie in Green Belt land for which National Government had promised protection. Councils are specifically required to take into account policy constraints such as Green Belt in setting housing targets. There is concern that NHDC is being unduly influenced by landowners and developers and not formulating its own ideas. Large parts of North Herts, which may be more suitable, have not been considered.

Readers of this Newsletter will know that we have fought for many years "To preserve for all time the open green space to the north of Stevenage known as the Forster Country." So, naturally, our focus is the North Stevenage strategic site (Area 219). Members were informed of the significance of the proposal and asked by us to complete their own personal responses. Our arguments will be reinforced by those of GASP (Graveley Against SNAP Proposals) as such a development would overwhelm that village and coalescence of Stevenage and Graveley would be unwelcome to us both.

Stevenage was planned as a New Town for 60,000 inhabitants. It has already expanded to 80 – 90,000 and is beginning to lose the benefits for which it was designed. The therapeutic value of green space and proximity to open countryside is undisputed and we do not want to lose it.

Hertfordshire is already the second most densely populated shire county in the United Kingdom and an addition of 10,700m homes would make it the first. Such an increase would be detrimental to the quality of life of current residents, particularly of the Old Town and Woodfield areas. There would be unwelcome new roads with increased noise and congestion and more stress on already overused water supplies.

Instead of large areas of new housing in specified limited areas creating mini-towns, such as we have in Great Ashby to the north east, every community should be required to build a small percentage of the required new homes – if, indeed, so many really are required.

It would not be advisable to create another new community straddling the boundary between two local councils. Like Great Ashby, the proposed development would adversely affect Stevenage residents, using Stevenage facilities whilst paying Community

Charges to North Herts. It would not help to regenerate Stevenage.

Development in North Stevenage runs counter to the council's own studies and publications. The NHDC website for Tourism and Culture states that the locality is mainly rural, consisting of countryside and small villages. It is designated as a Landscape Conservation Area. Views of the Chiltern Hills were recognized in the NHDC Landscape Study of 2011 whose guideline was to maintain the open character and long distance views of the area.

The strategic site pinpointed is 32 hectares yet this study stated that development over 5 hectares would be inappropriate. This is the only remaining farmland in Stevenage, historically important as the surrounding land of the original Saxon village of Stigenace.

Of special concern to us, of course, is the literary and artistic heritage of the area which has been encroached on and could be obliterated. E M Forster, Elizabeth Poston and Sir Malcolm Williamson all lived in Rooks Nest House and Forster immortalized it in *Howards End*.

Readers of local papers will know from the Letters pages that these development proposals are causing controversy. Stevenage Borough Council has yet to publish its own housing growth plan so our arguments will need to be repeated when they do, should they suggest a site adjoining that of North Herts, south of Area 219. The fight to save Forster Country thus continues!
